

**INFORMATION ON THE PURCHASE OF TREASURY SHARES OF NEXI S.P.A.  
COMPLETION OF THE BUYBACK PROGRAM LAUNCHED ON FEBRUARY 22, 2023**

*Milan, March 14, 2023* – Nexi S.p.A. (“Nexi”) announces that, during the period between March 10, 2023 and March 13, 2023, it has purchased on Euronext Milan no. 212,439 Nexi ordinary shares (ISIN IT0005366767) for an aggregate amount of Euro 1,580,447.29, in the context of the authorization granted by the shareholders’ meeting held on May 5, 2022.

On the basis of the information provided by the intermediary appointed to carry out the purchases Intermonte SIM S.p.A. (code: INTSITM1), the following table summarizes, in daily and aggregate form, the purchases of Nexi ordinary shares carried out by the intermediary on Euronext Milan during the above-mentioned period:

Attached to this press release there is a daily breakdown of purchase transactions made during the reporting period.

Following the above-mentioned transactions, the share buyback program launched on February 22, 2023 on the basis of the above-mentioned shareholders’ authorization has been completed. The Board of Directors reserves the right to launch in the future new buyback programs, to be implemented, in any case, within the limits of the resolution of the shareholders’ meeting held on May 5, 2022, it being understood that any such new program will be promptly communicated to the market in compliance with the terms and conditions provided for by applicable laws and regulations.

As a result of the purchases disclosed today and considering the ordinary shares previously held in the company’s portfolio, as of today, Nexi holds n. 803,291 treasury shares amounting to approximately 0.06% of its share capital.
